No change plans, says

BENGALURU: Infosys CEO Vishal Sikka on Friday said there is no change in its buyback plan under which it could return as much as ₹13,000 crore to its shareholders.

The board of the embattled company - which saw its CEO Vishal Sikka step down today amid founders' allegations of corporate governance lapse - is scheduled to meet tomorrow to consider the buyback proposal.

"There is no change in buyback plans. We have made a commitment on how much and when to return cash to shareholders," Infosys board Chairman Seshasayee said at a conference.

The share buyback - which will be the first in the company's 36-year history - has been a long-standing demand by some of the founders and high-profile former executives, who have been pushing Infosys to return surplus capital to its shareholders.

"None of the things that have been set in motion will be stopped," Seshasayee said responding to a specific question on the fate of the buyback amid the high-profile departure of the CEO.

There are concerns that the investors' sentiment could take a beating following
