पुलिस कर्मियों के खिलाफ कार्वाई की गई है क्योंकि पूर्व में भी इस तरह की घटनाएँ होने की खबर है। मानवाधिकार आयोग ने एक बयान में कहा, बैरिकेड की तार को इस तरह लापरवाही से छोड़ना अपने कर्तव्य का अपराधिक उल्लंघन करने जैसा है। पुलिसकर्मियों के इस लापरवाही भरे रवैये की वजह से एक कीमती जिंदगी चली गई। यह मानवाधिकारों के गंभीर उल्लंघन का मामला है। आयोग ने केंद्रीय गृह सचिव, दिल्ली के पुलिस आयुक्त को नोटिस जारी करके इस मामले की विस्तृत रिपोर्ट मांगी है। मानवाधिकार आयोग ने बताया कि दोनों अधिकारियों से चार सप्ताह के भीतर जवाब मिलने की संभावना है। एक पुलिस अधिकारी ने बताया है कि यह घटना सात फरवरी की रात की है जब बाइकसवार अभिषेक अपने घर लौट रहा था। आयोग के बयान में कहा गया है कि लापरवाही से हुई मौत का मामला नेताजी सुभाष प्लेस पुलिस स्टेशन में दर्ज कराया गया है।
